Assessment, planning, implementation, and evaluation of all bodily systems, as well as treatment of selected emergencies will be covered, as guided by the ENA Core Curriculum. OBJECTIVES

At the conclusion of this program, the participant will be able to -

1. Assess and provide emergency nursing care to the patient with neurological emergencies.
2. Describe the anatomy and physiology of the cardiac system and assess and provide emergency nursing care to the patient with cardiac emergencies.
3. Assess and provide emergency nursing care to the patient with pulmonary emergencies.
4. Assess and provide emergency nursing care to the patient with orthopedic/wound emergencies.
5. Discuss professional issues and legal implications of various emergencies.
6. Assess and provide emergency nursing care to the patient with general medical emergencies.
7. Assess and provide emergency nursing care to the patient with multi-system trauma and/or shock.
8. Assess and provide emergency nursing care of the patient with GI emergencies.
9. Assess and provide emergency nursing care of the patient with a GU/GYN/OB emergency.
10. List concepts of emergency nursing care to the patient with substance abuse, toxicological, psychosocial, or general environmental emergencies.
11. Assess and provide emergency nursing care to the patient with Maxillofacial and ocular emergencies.
