## TCRN INFORMATION

The Trauma Certified Registered Nurse (TCRN™) exam incorporates the body of knowledge in trauma nursing across the continuum of care, from injury prevention through reintegration to home. Upon successful completion of the certification exam, the TCRN credential is valid for a period of 4 years.



## COURSE TOPICS

**This dynamic and interactive TCRN review course is designed and developed to prepare nurses specializing in trauma care to take the TCRN examination. Course topics will include:**

- Succeeding at the TCRN Exam
- Shock (hypovolemic shock, septic shock, and obstructive shock)
- Psychosocial Aspects of Trauma
- Professional Issues (trauma designation, legal issues, performance improvement, evidence based practice, disaster management)
- Surface and Extremity Trauma (Wounds, burns and orthopedic trauma)
- Trunk Trauma (chest, abdominal and genitourinary trauma)
- Obstetrical Trauma
- The Continuum of Trauma Care (injury prevention, pre-hospital care, Intra-hospital care, rehabilitation, end of life issues)
- Head, Neck and Facial Trauma
- Interactive Group Exercises

### Exam Eligibility Requirements and Recommendations:

#### Required -

- To qualify for the exam, you must hold a current, unrestricted Registered Nurse license in the United States, or its Territories.  
A nursing certificate that is equivalent to a Registered Nurse in the United States is also acceptable.

#### Recommended -

- Two years of trauma nursing experience at an average of 1,000 practice hours per year across the trauma care continuum (trauma nursing practice defined as providing direct care, supervision, education, and advocacy for trauma patients and their families).
- Twenty (20) to thirty (30) hours of trauma specific coursework across the trauma continuum.

Successful completion of the program requires verified attendance for 90% percent of the program and a completed online evaluation by the participant within 10 calendar days of the program date. A certificate of completion will not be made available for you if the evaluation is not completed within this timeframe. No partial credit available.

**Of Note:** Licensees should verify with their state licensing board for acceptance of continuing education units. Save the course outline and certificate of completion and contact your own board or organization for specific filing requirements. Upstate AHEC does not provide assistance with individual filing requirements.
